Order and Safety

Jokkmokk Market is Sweden's oldest market with an unbroken tradition dating back to the early 1600s. Market trading is the heart of Jokkmokk Market, which is renowned for its pleasant atmosphere and inclusive environment. As a market vendor, you are an important part of this!

We, as the market organizers, we are responsible for this event.

The core values of Jokkmokk Market are based on responsibility, respect, and equal value.

Application

- Applications must be submitted using Jokkmokk Market's official application form no later than October 31.
- Confirmation and invoice will be sent separately by post once the market spaces have been allocated in early December.

Marketplace

The market area is used for market trading as well as for the organizer's own activities.

- It is **mandatory** to register at check-in when you arrive at the market area. At check-in, you will receive information, an electricity tag (to be attached to the power cable if electricity has been purchased), a garbage bag, and possibly keys or other items.
- A market stall measures 3 x 3 meters. If you need more space for your trailer, you must book additional stalls. Space for trailers, motorhomes, or trucks is limited in the market area. Vehicles must not exceed the width of the booked stall.
- We rent out an empty space, meaning you are responsible for bringing all necessary equipment – such as tables, shelter (roof or tent), and any other props.
- The assigned market stall is valid for all market days of the year.
- A sign with your company name and contact details must be clearly visible at your stall.
- There must be at least 4 meters of distance between caravans, motorhomes, and similar vehicles.
- There must be at least 4 meters of distance between buildings and sales stalls.

- Emergency services (fire department, ambulance, and police) and their vehicles must be able to access the market area without difficulty.
- Facade and ground signs for fire stations and associated signage must not be blocked.
- The use of liquefied petroleum gas (LPG) must be declared in the application.
If using more than two (2) P11-type gas cylinders, a permit for handling flammable goods must be obtained in advance from the Jokkmokk Fire Department.
Application forms are available on the Jokkmokk Municipality website.
A fire extinguisher must be available at every location where LPG is used.

Setup Times for Market Stall

- Wednesday: 13:00–20:00
Thursday: 07:00–10:00
During these times, staff will be present to guide you to your designated market stall and ensure the electricity tag is properly attached.
- Your market stall must be fully set up no later than 10:00 on Thursday, the opening day of the market. A site inspection will be conducted at that time.
- Space for trailers, motorhomes, or trucks is limited within the market area.
- For accommodation, vendors with caravans, motorhomes, or buses are referred to local campsites.
- Area H must remain completely free of vehicles, trailers, motorhomes, buses, and caravans throughout the entire market period.

Market Opening Hours

The market is open Thursday to Saturday, 10:00–18:00.

- During these hours, your stall must be staffed.
If your goods sell out, a sign with this information must be placed at your stall, which otherwise must remain intact.
- Sales outside the stated opening hours are not permitted.
- For safety reasons, no vehicles may be driven within the market area during opening hours. Vehicles may be started no earlier than 18:00, and this applies to all market days.

Food sales

- Information and forms regarding food sales regulations can be requested from the market organizer.
- Food sales outside the stated opening hours are not permitted.

Product Range

- The range of products must match what was stated in the application.
If the vendor sells a significantly different range of products, the organizer reserves the right to dismiss them, and no refund of the stall fee will be issued.
- Products and activities must not be discriminatory or promote drug use.
We strongly reject all forms of violence.
- Vendors are responsible for obtaining any necessary permits themselves.

Note: Certain products are not permitted for sale during the market.

Vendors are required to stay informed and comply with Swedish laws and regulations regarding prohibited goods

Electricity Connection

- Electricity must be ordered with the market stall application.
- An electricity tag from the market organizer, as proof of purchased electricity, will be provided at check-in.
- The electricity tag must be attached to the cable using a zip tie.
- If purchasing 16 A or 32 A outlets, vendors must bring their own power distribution unit.
- If capacity allows, additional electricity may be purchased on-site.
- An electrician will inspect all electrical connections.

Vendors are responsible for using approved, high-quality electrical equipment.

We reserve the right to cut power if the equipment causes inconvenience to others or poses a safety risk.

Note: Electricity is only available from Wednesday at 1:00 PM until Saturday evening at 6:00 PM.

Waste and Garbage Management

- Vendors are responsible for sorting their own waste.
- Waste is collected every morning in two categories: cardboard and other waste.
- Please avoid blocking access for waste collection.

Insurance

- Vendors are recommended to have insurance appropriate for the event.

Payment and Possible Cancellation

- Payment for the market stall must be received by the due date stated on the invoice.
- If payment is not received on time, the organizer reserves the right to assign the stall to another vendor.
- Any cancellation must be made no later than four weeks before the start of the market week. Otherwise, the full invoice amount must be paid.
Cancellations made later are only accepted upon presentation of a medical certificate.
- An administrative fee of SEK 200 applies to cancellations.
- The stall may not be transferred to another vendor without the organizer's approval.
- If you can't attend, contact the organizer immediately to cancel your stall.

We follow the recommendations and regulations set by Swedish Market Trade (Svensk Marknadshandel).
